WASTEWATER (Mr. Berenato, Chair):

Resolution 20-5-115: Authorizing shared services agreement between Atlantic County Utilities Authority and the County of Atlantic for Operation and Maintenance of Atlantic County Nursing Home (Meadowview) Pumping Station, the Gerald L. Gormley Justice Facility Grinding Station, and Lake Lenape and Mays Landing Campsite Pumping Station. Annual revenue to the ACUA is \$44,035.39.

Explanation: Renewal of agreement whereby the ACUA will provide routine maintenance and response services for the term 9/1/20 to 8/31/23.

Explanation: Renewal of agreement whereby ACUA Wastewater Systems staff will provide Pinelands Park Landfill pump station maintenance services for the contract term July 1, 2020 to June 30, 2023.

Explanation: Renewal of agreement whereby ACUA Wastewater Systems staff will provide ACUA Landfill pump station maintenance services for the contract term July 1, 2020 to June 30, 2023.
