

NOTICE OF ADOPTION OF BOND RESOLUTION

NOTICE IS HEREBY GIVEN that the Atlantic County Utilities Authority (the "Authority") on the 19th day of March, 2026, adopted a resolution entitled "RESOLUTION OF THE ATLANTIC COUNTY UTILITIES AUTHORITY AUTHORIZING THE ISSUANCE OF UP TO ONE MILLION FOUR HUNDRED THOUSAND DOLLARS (\$1,400,000), AGGREGATE PRINCIPAL AMOUNT OF ITS WASTEWATER REVENUE BONDS, AND THE ISSUANCE OF CONSTRUCTION FINANCING PROJECT NOTES IN ANTICIPATION OF THE ISSUANCE THEREOF, CONSTITUTING A SERIES RESOLUTION UNDER THE RESTATED GENERAL RESOLUTION AUTHORIZING WASTEWATER REVENUE BONDS OF THE AUTHORITY ADOPTED JUNE 16, 1994, AND TAKING RELATED ACTIONS" (the "Bond Resolution") approving and authorizing the issuance of wastewater revenue bonds and of construction financing project notes in anticipation of the issuance thereof, in an amount not to exceed \$1,400,000 (collectively, the "Obligations") to (i) implement an advanced upgrade to the microplastic collection system at the City Island Wastewater Treatment Plant (1801 Absecon Boulevard, Atlantic City, NJ 80401) which project involves transitioning the existing microplastic collection pilot system into a fully integrated, permanent system, incorporating automated sensing and operational enhancements to optimize the efficiency and performance of the microplastic collection at the Authority; (ii) pay the costs of issuance associated with the Obligations; and (iii) take any and all other actions deemed necessary, desirable and convenient in connection with matters detailed herein (collectively, the "Project"). Copies of said Bond Resolution are on file and are available for public inspection in the office of the Atlantic County Utilities Authority, 6700 Delilah Road, Egg Harbor Township, NJ 08234 between the hours of 7:00 a.m. and 4:00 p.m. Any action or proceeding of any kind or nature in any court questioning the validity of the creation and establishment of the Authority, the validity or proper authorization of the Obligations provided for by such Bond Resolution or the validity of any covenants, agreements, contracts or documents provided for or by said Bond Resolution shall and must be commenced within twenty (20) days after the date of publication of this notice. This Notice is published pursuant to the Municipal and Counties Utilities Authorities Law, *N.J.S.A. 40:14B-1 et seq.*, and the acts amendatory thereof and supplemental thereto, and in accordance with the above Bond Resolution of the Authority. This notice was first posted on the 20th day of March, 2026 on the Authority's official website and is available thereon for at least one week (seven (7) calendar days) thereafter.
