Resolution 22-8-172: Authorizing the award of an alternate method contract for Professional Services to DeMaio's, Inc. for the performance of Enhanced Fluid Recovery Events at the Broadway Pump Station and preliminary work at the Seaview Pump Station for Soil Remediation and Groundwater Sampling. Total amount not to exceed \$18,088.50, for the contract term September 1, 2022, to August 31, 2023.

Explanation: To perform a preliminary investigation for soil remediation and ground-water sampling.

Resolution 22-8-173: Authorizing a contract amendment with TTI Environmental, Inc., for the Static Head Test on new Tank 6. Amount of increase is \$450.00.

Explanation: To replace an annual test protocol with a Static Head Test involving Hypo Tank #6.

Resolution 22-8-174: Authorizing an agreement with Caesar's Entertainment Operating Company, Inc. for Grease Recovery Units Inspection Services for Caesar's Atlantic City property.

Explanation: Estimated revenue for 24-month term, from October 1, 2022, to September 30, 2024, is \$13,655.20.

Resolution 22-8-180: Authorizing Memorandum of Agreement with New Jersey Department of Environmental Protection for participation in the New Jersey Watershed Ambassadors Program. Annual revenue to the Authority is \$1,000.00.

Explanation: Renewal of agreement whereby the Authority will act as host agency for a 12-month term from September 8, 2022, to August 31, 2023.

Resolution 22-8-181: Authorizing the award of a contract in Bid No. 2022-SW-08 for Installation of Landfill Gas Wells (Routine and Emergency) to Keller Industrial, Inc. Amount is \$271,500.00, for the contract term September 1, 2022, to August 31, 2023.

Explanation: Awarded to lowest responsible bidder.

<u>CENTRALIZED MAINTENANCE & ASSET MANAGEMENT</u> - Mr. Berenato, Chair

Resolution 22-8-182: Authorizing a contract amendment to contract with Lawson Products, Inc. for Industrial/MRO Supplies & Equipment through Omnia Partners Cooperative Purchasing. Amount of increase is \$7,500.00.

Explanation: Adding funds to original contract due to a manufacturing change on hydraulic hoses and fitting, requiring the purchase of several new items for servicing.

Resolution 22-8-183: Authorizing a contract amendment to contract with Groff Tractor for Case Equipment Repairs & Services through the ESCNJ Cooperative Purchasing System. Amount of increase is \$70,000.00.

Explanation: Adding funds to original contract to cover the cost of three (3) major repairs to the Case 621 Loader and to Excavator 74.

Resolution 22-8-184: Authorizing award of contract to Longo Electrical/Mechanical for Wastewater Industrial Maintenance Supplies and Repairs through the North Jersey Wastewater Cooperative Purchasing System. Cost is \$70,340.00.

Explanation: For repairs of effluent pump and motor, plus testing.

Resolution 22-8-185: Authorizing a contract amendment to contract with Riggins, Inc., for Bio-Diesel Fuel under NJ Start State contract. Amount of increase is \$455,000.00.

Explanation: Due to major price increases.

Resolution 22-8-186: Authorizing a contract amendment to Riggins, Inc., for Unleaded Gas through NJ State Contract. Amount of increase is \$85,000.00.

Explanation: Due to major price increases.

Resolution 22-8-187: Authorizing a contract amendment to contract with Graybar Electrical Technologies, Inc., for Electrical Equipment and Supplies through the Omnia Partners Cooperative Purchasing System. Amount of increase is \$18,000.00.

Explanation: For various equipment and electrical supplies for generator load banking.

Resolution 22-8-188: Authorizing the award of a contract for Professional Services to Hawkins, Delafield & Wood, LLP, for review and technical assistance in developing specifications for RFP seeking vendors to partner with the ACUA for an onsite Bioenergy/Alternative Waste Disposal Technology Facility.

Explanation: For assistance with developing specifications for RFP and preparing a draft contractual agreement. Amount is not to exceed \$10,000.00, for contract term September 1, 2022, to August 31, 2023.

Resolution 22-8-189: Authorizing a Grant Agreement with NJDEP to fund an electric collections vehicle and an electric charging station. Amount of grant is approximately \$453,214.00.
